### **EXAMPLES OF IMPERMISSIBLE STATEMENTS:**

- "I have finally found an easy way to improve my family's financial situation thanks to SNiP Nutrigenomics."
- "I am amazed at the ease of building this business. This product sells itself."
- "I would like to share what can keep you healthy and add financial freedom to your life. Message me for details!"
- Lifestyle Claims Visual images that depict a lavish lifestyle on a platform that promotes the business can give the impression of a certain hypothetical outcome and can be just as deceptive as specific income earnings.

#### SNIP NUTRIGENOMICS'S INTELLECTUAL PROPERTY

SNiP Nutrigenomics's Intellectual Property and protected materials - such as trade names, trademarks, service names, and logo - are of great value to SNiP Nutrigenomics and are not to be used in Internet domain names (URL), e-mail addresses, titles of social media pages, web pages, or blogs. Using these terms is representative of an Official Corporate SNiP Nutrigenomics site or page and is misleading to the public. Instead, any platform on which an independent wellness professional, retailer or affiliate uses to promote SNiP Nutrigenomics products or affiliate opportunity must identify as an "Independent Affiliate with SNiP Nutrigenomics."

You may post your own testimonials and those of others who have given you express written permission to do so. Testimonials must be truthful, fair, and not misleading. Please do not use "weight loss" or medical claims in any description in which results are shared. All personal testimonials and pictures shared must include a statement that you are an "Independent Affiliate with SNiP Nutrigenomics," and all testimonials should include the following conspicuous disclaimer: The results depicted in the photo (or described in the testimonial) are unique to the individual and achieved only through dedication to a specific diet and exercise regimen in conjunction with SNiP Nutrigenomics dietary supplements.
